ZABEL SHOWS HOW TO MINERS DRAGGED BECOME TRUSTS' JUDGE FROM HOMES TO

(Editor's Note.—Few people realize the sort of men who are made judges. Most people have a sort of reverence for any man who can talk in a lan-guage they can't understand and who can send them to juil. That is about car sound reasoning as "respect" for the courts is usually founded on. In the article by Walker M. Yeatman it was shown what sort of decisions judges make in certan classes of cases against workingmen. The following article has been prepared by Socialist against workingmen. The following article has been prepared by Socialist District Attorney Winfred C. Zabel of Milwaukee County, Wis. It is part of the publicity work in the interest of electing Socialist judges to the bench in Cook County. In addition to its appearance today in The Chicago Daily Socialist the same article appears in the Jewish Labor World, a Socialist weekly. The chief interest in Zabel's article is that it shows the kind of man who is most often made a judge in who is most often made a judge in Cook county. He describes a character drawn from the ideal corporation judge. Some judges fall short of that stan-dard, but it is the standard toward which most of them strive.)

They were experts also in the wrecking of railroads by a way only known to high finance, and whon the cost of living exceeded the wages paid by the corporation to their "hands," this legal combination knew from what judge they could obtain the best kind of injunction with which to paralyze the arm of labor and to cleave their tongues to the roof of mouths, so that the labor union no longer walk, nor talk, nor

"Protected Property"

This firm was a strong believer in the writ of injunction and a strong dis-believer in the writ of habeas corpus. John Slick was an adept scholar, and while he profited by the experiences obtained with Catchem & Skinem, they profited by his ability to serve their wealthy clients. In recognition of his services they made him a member of their firm and called it Catchem, Skinem & Slick. He soon became a pillar of society, one of the leading members of the commercial world.

Became Prominent

He attended church regularly and even lead a Sunday school class. He was elected a national committeerman of the Republican party, and always helped to nominate a "safe and sane"

When the president visited his city he was one of those who were delegated to receive him on behalf of all the people. He was eminently successful in his practice, and by manipulating stockholders and corporations of whom he was the legal advisor, he was able to freeze out the minority and combine with competitors in business.

This made him rich and famous.

Went to Legislature

Every time the legislature met he would spend much time in the capitol and with the capital of his wealthy clients helped to make the chosen repents helped to make the chosen rep-resentatives of the common people see the foolishness of reducing the price of gas from \$1.00 to 60 cents per 1,000 cubic feet, and of the impossibility of operating railroads with big dividends on a two-cent per mile rate of fare. When a United States senator was

when a United States senator was to be elected to represent "Pork and Lumber" in the upper house, it was John Slick who spent the money of his wealthy citents in a "legal yet ju-dicious way." This established him as gladiator in the political areas, a gladiator in the political arena, on behalf of "vested interests," so that when a man like Judge Cruppgross, on the bench, decided that his activity on the bench had reached its greatest scope, or refused to be renominated. John Slick was at once remembered as one who could be trusted to protect the sacred interests from the ever growing attacks of the common people clamoring for justice.

clamoring for justice.

Named for Bench

He was nominated as "a non-partisan" candidate for Circuit judge. The great daily papers, owned by the gas and railroad interests, by the banks and corporations, took particular delight in polating out the importance of electing a "non-partisan judge"; one who knew no class or interest, no party or politics, and such a one for that position was personified in John Slick. Great meetings were called in his behalf. Advertisements appeared in every paper, but no one seemed to know who paid for his campaign expenses. The working class were told that he would be their friend, and they cheered him to the scho.

Others there were who lost a limb and mangled their flesh in the workshops of Judge Slick's former clients, because of de fects in some broken-down machine The boss had been asked to have the machine repaired and promised he would do so, and told the hand to go back and work until it could be done. The "hand" went to work again and lost his limb in consequence. Crippled and poor, he was forced to seek redress in court, before Judge Slick, who read his constitution every night before he went to bed. The jury was empaneled. In Same Class

The defendant's corporation lawyer, one of the very class from which Judge Slick had graduated to the bench, made a motion that the plaintiff's case be dismissed because the plaintiff had "assumed the risk"

Judge Slick had in his days as a law yer made similar motions in similar cases many times, and they were often granted by his predecessor; so, in keepin gwith the judge-made law, and in in gwith the judge-made law, and in conformity with his early training and hon-partisan spirit on the bench, the motion was granted and Judge Slick dismissed the case, while justice wept and hung her head with shame.

Law Is Passed

This happened frequently and the people thereupon passed a law provid-ing that no workingman shall be held to assume the risk incident to a de-fective machine when told by his boss to continue at his work. The army of cripples was increasing day by day, and the non-partisan justice of Judge Slick was breeding anarchists with himself the unknowing teacher by ex-ample. ample

Another victim of the iron teeth of in dustry, now armed with this law passed by the legislature, appeared for redress before Judge Sick, the "friend of the common people."

But He Did Not

Strely he must recover. He was not negligent himself, for hadn't the boss promised to repair the defect in the broken-down machine and told him to continue at his work until it could be fixed? Didn't the workingman have family to support, who needed every cent of his meager wages? Now with his right hand gone he appeared in court for damages and raised his leit to God to tell the truth upon the witness stand.

ness stand.

Surely Judge Slick would give him justice, for didn't he vote for him on the non-partisan ticket? Ah, what disappointment was in store for him!

He had not reckoned with the constitution, the same constitution which Judge Slick had studied standard. Judge Stick had studied every night.

Doesn't it say that the sacred rights of contract must remain inviolate that every man has the right to re-fuse to work at any time his employ-ment becomes unsafe; that the work-

determined, with power to fix the conditions of the struggle, hardly doubts the issue, bent only upon securing the perpetuity of its ancient regime.

The drowsy pensioners and sycophants of "Law and Order" in the crisis only the just attempts of right to find and punish one or two murderers; and over the newspapers are spread the pratings of their informants, paid mouthpieces; the journalistic puppets, who rattle and chatter, moved by invisible strings. The thoughful and observant, on the other hand, remembering many events in the long past, and particularly 1887. Homestead, the great railway struggle of 1894, the fight in Idaho, the Moyer, Haywood and Pettibone prosecution, and the scenes in the Pennsylvania coal fields that this situation bodes much more. They know that organized capital, with a finesse worthy of its object, lets no promising event escape it, but immediately fixes upon every possible happening of a violent nature as a means for the curbing of labor. They know that its opportunity in the present lies in Los Angeles, and that it is making the most of it.

Labor must be taught obedience and submission, that it may know its place, think the masters of labor. "Have we not used man from of old?" they ask; "and shall we not use him forever? Was he not made to serve?" And whispered between them in hours of extremest confidence can be heard the regret, "Why did we, in the past, urge free education upon the people? We thought it would make labor more efficient; it has made it a rebel!" Acts of violence are things for mammon to conjure with; they may be used, if carefully manipulated, to discredit and discourage labor; especially if they be acts against a manufacturing plant, or against the represen-

The sources of public opinion are, thereupon, poisoned for the occasion. Press, pulpit, the theater, the public platform, are bought, cajoled, deceived, as much as may be; and a trial of so-called conspirators is entered upon, with the complicated machinery of perjury, intimidation, class law, and money, all in order.

But what of labor, meanwhile? Organized, and organizing, se-

cretly and openly, according to the watchfulness or carelessness of capital, it approaches the "bar of justice" with confident mien and the will and the strength to fight. The bone and sinew of the world pours its little savings into the center of the struggle with a lavishness that astonishes and inspires those who would serve it in the conflict, and from all over the world where labor sweats and creates wealth, comes the cry and hail, "Courage, brothers!"

The proletariat has been looking at itself in the mirror of truth this long while, and from a dumb, patient and uncomplaining servant has risen to the stature of worth, independence and power. As capital has stealthily or openly aggregated and united, so labor has come together and united its millions of hands and heads. Threatencapital has stealthily or openly aggregated and united, so labor has come together and united its millions of hands and heads. Threatening to use its economic power in general strikes, co-operative industries, and allied plans, and examining with care the ballot which has been put into its hands, while it talks of new and vast political struggles exclusively on behalf of its class, it fears not the results at Los Angeles or anywhere; knowing that its day is dawning, while night begins to gloom above the madness of mammon's world.

Before now many men, devoted toilers, have died, or have rotted in prison for the sake of the cause. Thousands are ready to die in

in prison for the sake of the cause. Thousands are ready to die in same way, if needs be.

They who create all the worth and glory of the world must at some time, somewhere, possess full access to that which they have created. Prisons may burst with their crowds of the devoted friends of man; the gallows may fall, overweighted and broken by the bur-dens of sacrifice which they bear; blood may stain the streets, and dye the fairest fields of all the world with sanguine hues from the hearts of the struggling toilers, but labor marches on to emancipation. It has in it the force of destiny. Evolution leads it. Its prog-

The consequences of the crisis at Los Angeles will not be merely the conviction, nor yet even the freeing, of two men; in that court labor will triumph, as it has triumphed in a thousand crises; and it will return to the scene of its centuries-long struggle to take up the task where it laid it down, unable to stop, inspired by its very sufferings and desperation; taking hope even in despair, even in the face of apparent defeat; the new-made master of things, making ready for its task. Nature, herself, has at last spoken the doom of slavery with a waite which thrills at the doors of millions of hearts

The next associate justice appointed in 1795 by Washington was William Paterson, of New Jersey. Paterson was directly connected with the Van Rens-salner family, with the lords proprie-

tors of New Jersey, and was the right-hand auxiliary of Governor William Livingston, By family ties of various kinds Paterson was also connected with many other large landholding families. Stephen Van Renssalaer Paterson, a twin brother of William Paterson, was long a surveyor general of the lords pro-prietors of New Jersey. The mother of Stephen Van Renssalaer (the elder Stephen-there were father and son of that name) was a daughter of Philip Livingston, lord of Livingston major. After his graduaation from Harvard, in 1782, Stephen Van Rensslaer had been mar ried to a daughter of of General Philip Schuyler, hence by marriage becoming a brother-in-law of Alexander Hamilton. Stephen Van Reussalaer's second wife was a daughter of Justice William Paterson. The immensity of Stephen Van Renssalaer's estate may be judged from the fact that in Renssalaer and Albany counties, New York, he owner
