NEWPORT, Wales. Feb. 9 .- That the Labor party, with its forty votes in the forthcoming parliament, will demand radical legislation from the Liberals as the price of its temporary support, was indicated today by Keir Hardie, the labor member of parliament from Merthyr-Tydvil, in his inaugural address as president of the Labor party congress.

"Those who are expecting that the Labor party will be rent with Internal dissensions, and finally merge itself with the Liberals, are doomed to dis appointment," Hardle declared.

"We must maintain our freedom o action at all hazards. The Liberals treatment of some of our parliament ary candidates has not been such as Assistant District Attorney George to inspire our confidence.



BUTCHERS AGAINST

Dealers Oppose Dowling's Meat Regulation Resolution Before Aldermen - Defend Cold Storage.

Alderman Frank Dowling's bill proriding for the labeling of all meats and perishable foodstuffs placed in cold storage with a tag bearing the date of entering and leaving the warehouse, came up for a public hearing yesterday before the Aldermanic committee on laws and legislation.

The Alderman's proposed ordinance provides a penalty of not less than \$5 or more than \$50, for failure to have the time of storage label on all storage meats offered for sale by retailers.

The packers and their representatives vere present in force.

Mrs. Sophie M. Lobinger, represent ing the Women's National Progressive Suffrage League, talked swiftly for a number of minutes.

She said that a great number of women who are interested in wholesome goods and what should be done to protect the consumer were anxious to attend the hearing, but that they had not received any reply to their request to be permitted to come and

"We women who do the marketing are strongly in favor of Alderman Dowling's ordinance," she said. "Much that has been said here was irrelevant. The proposed ordinance will not interfere with cold storage in any way. It is not designed to hurt anybody's business. It merely says that people shall be informed just how long articles have been kept."

Frank Harvey Field spoke for the fish dealers. He said that the price of fish is less now than it has been for twenty years, and that the public can thank cold storage for reasonable prices and ample supplies. If it were not for cold storage, Field said, it would be impossible for New Yorkers to get fish for six months of the year. He was certain that the public is amply protected under the existing laws.

Alderman Dowling took exception to Field's statement that the price of fish has gone down. He said it is decidedly the contrary.

Used to Throw Fish Away.

"Why I can remember," he said when fish was so cheap that we used

"arue enough," said Field, "but there wan't any adequate system of cold storage in those days, and fish was thrown away because it couldn't be kept."

"Why don't we see fish peddlers on the streets any more?' inquired Alderman Dowling. "Because the city has made them

After Long Conference With the Rapid Transit Company, the Employes Do Not Get Anything.

(Special to The Call.)

PHILADELPHIA, Feb. 9.-After a conference lasting from yesterday morning until early today, President Kruger the Philadelphia Rapid Transit Company, and a committee from the Car Men's Union, failed to reach an agree ment on differences between the company and its employes, including the right to arbitrate a new scale of wages and the recognition of the union.

At the conferences discussion was based on a tentative agreement which had been handed to the company by the men last week. It's consideration was followed by the presentation of the company's stand in the matters under discussion, and every phase of the ques tions at issue were talked over in detail.

While po announcement of the action of the conferees was made when the meeting adjourned, it is understood that the greatest divergence of opinion is in the matter of recognition of the union. It has been demanded by the grievance committee of the Amalgamated Association of Street and Electric Railway Employes of America that Division No. 477, the local union, be recognized as representing the whole body of em-ployes of the company, to the exclusion of a similar committee appointed by the Keystone Local, No. 2, a rival union organized by the company and composed of Pinkerton spies, detectives, clerks, laborers—anything but conductors and motormen.

I'nion men, who have declared many times that the Keystone local has been fostered by the company, say that in the event of that body being recognized company legislation for the whole group of workers will be made on Keystor claiming a membership of more than half the total number employed, wish to reserve the right to confer with the company.



Barely a month passes by in which "woman suffrage" is not made visible and audible in parliament, on the platform, in the press. The latest triumph is the indorsement by both houses of the commonwealth parliament of a resolution testifying to the houses of the communitying to the ment of a resolution testifying to the beneficial operation of woman suf-frage in Australia. The resolution was brought forward by Dr. William Maloney, M. P., the first man to introduce a woman suffrage bill into an Australian legislature (Victoria, 1889), and runs as follows:

and runs as follows:

1. That this house testifies to the facts that after sixteen years' experience of woman suffrage in various parts of Australasia, and nine years experience in the commonwealth, the reform has justified the hopes of its supporters, and falsified all the fears and prophecies of disaster voiced by its opponents. 2. That, as foreseen by its advocates, its effects have been (a) to gradually educate women to a sense of their responsibility in public affairs; (b) to give more prominence to social and domestic legislation. 3. to social and domestic legislation. That Australasia experience convinc this house that to adopt woman suf-frage is simply to apply to the political sphere that principle of government that secures the best results in the do-mestic sphere—the mutual co-oper-

ation of men and women for the indi-vidual and general welfare.

The resolution was received with approving cheers in both houses. There is not one anti-suffrage mem-ber in either chamber nowadays; most of those who were formerly our op-ponents are pow quite hurt if we re-mind them of the fact, and the resi believe they took the platform as ad vocates of women's enfranchisement
