



### SCARECROWS IN THE CORNFIELD

Watch out for the politician who bases his claim to your vote on the ground that he is "unbossed," that he is "fighting the bosses," and that if elected he will take orders from no "boss;" which means, if it means anything, that he will do the "bossing" himself.

When you hear this, ask yourself how you will benefit by such a change of "bosses," and try to figure it out for yourself.

The fellow who is bossed by Roosevelt swears he won't be

bossed by Barnes, and the fellow who is bossed by Barnes repudiates the bossism of Murphy, and Murphy's tool in turn is loud in his declaration of independence against Barnes, Roosevelt and Flinn. All of them can see the other fellow's boss and hurl their oratorical scorn upon him, while all of them claim themselves to be independent of any boss. It is unimportant, even if true, and it isn't true at

The political boss against whom they all inveigh is but a puppet, a rag doll, a dummy, a scarecrow, behind which the real boss hides himself. The stuffing could be knocked out of all these dummies, and it would absolutely make no difference to you, as others would be instantly constructed. This kind of boss is being constantly manufactured and demolished, and there has been a long succession of them. In fact, the fellows who would tear them to

pieces would be the very ones most likely to take their places.

The real boss is the fellow who owns your job, the fellow who controls your bread through his ownership of the means of life. And that boss has been repudiated by none of these noisy "heroes." That boss is the capitalist-the capitalist class, rather-and the political boss that the others rage against is only his puppet, his

The real bosses are Morgan and Rockefeller and Ryan and Belmont and Archbold and Perkins, and scores of others of the same type, not Roosevelt and Barnes or Murphy and Flinn.

There is no more courage displayed in denouncing the latter

publicly than there is in demolishing a scarecrow in a cornfield.
You can go, say, to Little Falls, and denounce Murphy. Barnes

or Roosevelt to your heart's content, and you will not be interfered

But go there and point out publicly that the local woolen mill owners are paying their employes starvation wages and urge the latter to demand more, and you will have run up against the real boss. You will have said something, and the real boss will sit up and take notice at once.

Same in New York or anywhere else. You can fill the atmosphere with blatherskite about the sham bosses and nobody gives a hoot, neither the real bosses, nor the sham bosses. You have at-tacked nothing, said nothing, done nothing, and you count for nothing. You have merely wasted your time verbally demolishing a cheap scarecrow. And your courage will be attested only by fools who fear the scarecrow and imagine that his demolition somehow insures them safety and security to pick up a little more grain in the capitalist cornfield.

The Socialist alone points out the real boss. He doesn't denounce him; he explains him instead, and he explains the sham

Get after the real bosses on election day, and strip them of their ownership of your means of life by the Socialist ballot. Their scarecrows, the so-called "political bosses," are only constructed for the purpose of working on your ignorance through fear to keep you out of the cornfield which you have labored and cultivated, but which the capitalist owns. Take that ownership from him, and both himself and his political scarecrow will vanish and you and your class can enter the field and enjoy the harvest created by your labor. Vote the Socialist ticket, and smash all the bosses, real and sham. economic and political, the capitalist and his scarecrow, Rockefeller and Morgan, Ryan and Belinont, along with Roosevelt, Barnes Murphy, Flinn, Wilson and Taft.

No one else will or can do it for you. You will have to de-liver yourself from the bosses. You need no master. The working class—your class—needs no master. Abolish mastership with the Socialist ballot, and get rid of bosses of all kinds, now and forever.

## ON THE SIDE

As the campaign draws to a close, we are naturally urging all Socialists to make the most of the few days remaining by redoubling their activity as propagandists, and to this end more and more public meetings and an ever greater distribution of literature are being advocated. All of which is to the good. There can be no effort made too great to attract public attention to Socialism.

There is another form of agitation, however, much less spec-tacular, but probably not less effective, that should not be neglected -that is, the constant introduction of Socialism as a topic of consation in factory, mill and workshop, between man and man.

In the past fifteen years thousands of Socialists have lost their jobs and been sent wandering as emissaries of Socialism throughout the country as a result of their Socialist activity in their places of employment.

And probably in nine cases out of ten this activity has mainly taken the form of private personal conversation between the agi tator and his fellow workers rather than the making of public speeches and the open distribution of literature.

There is no way of figuring out the effect of this kind of work,

but nevertheless it must be enormous, and it is feared by the employing class as much as other methods of agitation, to say the least. There are now a few places in the country where a Socialist will not necessarily forfeit his job, even if he is known to talk Socialism to his fellows constantly. And this is not the result of a change of heart on the part of the employer, but rather that the work has had such effect as to make the "punishment" useless. There are shops and factories so crowded with Socialists now that the employer may well hesitate before discharging a workman for merely talking Socialism.

While we ask no one to imperil his livelihood, at the same time point out that this work can be done almost everywhere within certain limits and with a certain degree of caution, and that it is work of the most telling character for the Socialist movement, even

if the effect of these "shop talks" cannot be accurately measured.

There are hundreds of thousands of workingmen in shops and factories who intend to vote one or other of the old party tickets. The most reasonable and intelligent of these—for there are degrees of intelligence among them—should be selected by the Socialist agitator as material to work upon pending election day. Special attention should also be paid to the intending Bull Mooser, particularly those who are not too far gone in hero-worship, and who show signs of considering the material interest of their class as show signs of considering the material interest of their class as being in some way bound up with Roosevelt's election. These people should be approached tactfully and drawn into argument, which should be conducted on the Socialist side with whatever coolness, judgment and skill the speaker is capable of, and no needless offense should be given.

Hundreds of thousands of workingmen have doubtless been bught to Socialism in this manner as the initial presentation of the subject, and while more public methods are of course also indispensable, this method should by no means be neglected. A word for Socialism is always timely, no matter where spoken, and no word spoken for Socialism is ever really lost.
